- d) The Lessee has examined the fishing equipment and that it is in good working condition (except as noted in the description below) prior to renting.
- e) Deposit will be refunded when items are returned on agreed date in the same condition as when it was rented out.
- f) Col JJ Parr Sports may terminate this agreement for failure by the Lessee to comply with the terms of this rental agreement in which equipment can be requested back into the lenders possession.
- g) Late returns will be charged ONE (1) day's fees for each 24hr period late. After 7 days the equipment costs will be charged to the renter through their unit CO.
- h) A valid Alberta Fishing License needs to be purchased prior to signing out fishing equipment.
